Title: Trustee

Accountable To: The Chair of the Board

RolePurpose:

Operate as part of a diverse leadership team, ensuring high standards of governance and diversity of perspective are evident across the board.

Competently deliver trustee duties, and cooperate effectively with others in delivering Works+ vision, mission and values.

Ensure that high-quality relationships are developed with internal and external stakeholders.

Offer ideas, feedback and suggestions that help challenge the status quo.

As a trustee you will:

- Ensure our charity is effectively governed and administered
- Ensure our charity complies with its own governing document
- Ensure money is spent in pursuance of our charitable objectives
- Ensure our charity remains stable

- Attend board meetings and contribute to discussions on our activities, targets and achievements
- Help set our policies, define our goals, and evaluate our performance
- Ensure equality, diversity and inclusion are at the heart of every decision we make

Other duties:

In addition to the above statutory duties, each trustee should use any specific skills, knowledge or experience they have to help the Board of Trustees reach sound decisions. This will involve:

- Attending meetings; reading and scrutinising papers in advance
- Leading and contributing to discussions
- Participating in trustee training and development programmes
- Staying informed about the activities of the organisation and issues that affect its work
- Offering up any special insights during trustee deliberation
- Providing suggestions on new initiatives

Person Specification

An effective trustee can come from any walk of life; your personal values are just as important as your skills and experience.

As a trustee you will need:

- Commitment to the organisation
- Team Work Skills
- Independent judgement
- Ability to think creatively
- Willingness to speak your mind

- Ability to challenge and question constructively
- A willingness to learn
- Understanding and acceptance of the legal duties, responsibilities, and liabilities of trusteeship



You may also have:

- Risk governance understanding and managing the risks we face at the human, property and charity levels
- Scenario planning enabling decisions to be flexible dependent on circumstances
- Accountability working cooperatively at all times
- Experience with youth employability either as a participant or professional.

These skills would be beneficial, but are not a necessary requirement.

Terms of Appointment

- Works+ Board of Trustees meets every 6 weeks in Galashiels or via Teams (1-2 hours).
- The Board meets once a year for Strategy Development/Review sessions (3-5 hours).
- The Board may allocate sub-committees to research and recommend special areas of interest, policy or opportunity (1-5 hours a month).
- Trustees should aim for full attendance at board, sub committee and strategy meetings, unless there are exceptional circumstances.
- Works+ holds a register of interests. Trustees are asked to provide an update of any new interests so the register is always up to date.
- Serving as a Trustee is on a voluntary basis however expenses can be covered.
- All Works+ Trustees require a PVG Certificate and Child Protection Training. This will be covered by the organisation. Additional training and learning in the role will be provided.
